

Attendance Counseling Team 360⁰ (ACT 360)

Evolution's Attendance Counseling Team 360 (ACT 360) has expanded into Huntingdon, PA. ACT 360 is a proven intervention/prevention program already fully operating in the neighboring Blair County by Evolution. Collaboration was extensive with Huntingdon Area School District, Huntingdon County Children's Services, JPO, Law Enforcement and Intermediate Unit 11 who have all identified the need for this program. ACT 360 allows students who reside in Huntingdon County to access help for students who struggle with attendance. ACT 360 is an intensive prevention/intervention counseling program that helps Huntingdon county school aged youth and their families set and meet their goals for success. This model is unique to targeting attendance issues from a 360 degree approach. The Attendance Counseling Team will be available for routine scheduled family/youth appointments, court hearings, provider meetings and school meetings. The ACT 360 program is typically involved with youth/families for around 3 to 4 months. The program will focus on whatever treatment modality best matches to the family/youth as identified by the family/youth and counselors. As part of the program, family and individual meetings will be facilitated by counselors who are trained in Motivational Interviewing. The referred families and youth will not need to be open with CYS or JPO to receive services. When working with a family, the team will be made up of two counselors. One counselor will work primarily with the parents while the other works with the youth. Individual and family meetings are all utilized to help the family meet their goals. Individual counselors will follow that family/youth as they attend court hearings, school meetings, provider meetings, etc., to ensure successful engagement and motivation. ACT 360 describes an all-encompassing approach of strength based systematic care to help students and their families reach their goals for success. The family/youth's core supports are identified ensuring optimum success in achieving his/her educational goals. The Attendance Counseling Team works in collaboration with the family to identify and reduce risk factors that have led to truancy issues in the family's past. Evolution Counseling Service's ACT 360 Counselors will work individually with the student and family to offer effective strength-based counseling services. The benefits of which can be far reaching for years to come. Identifying Huntingdon County families/youth at any point and time of the year can help support the youth and family for positive change and to eliminate road blocks such as school policies that prevent youth from passing to the next grade. ACT 360 counselors are strengths focused in their approach to helping families. The counselors will help advocate, engage, motivate and applaud the smallest of steps in the right direction. The key is to offer counseling that matches to that student and family for additional supports outside of and inside the school systems. This may include tutoring, transportation, individual counseling, peer groups, family activities, etc. Participation from the parent/guardian/student is key to completing the program and ensuring positive growth. Evolution Counseling's Attendance Counseling Team will work with the parents and the student to achieve goals related to their success in school. Meeting on a weekly basis is a required part of participating in the program. This is an important component to reaching not only the long-term goals of the family but to also target important issues immediately like attendance, tardiness, classroom behavior, and grades. ACT 360 will start immediately upon the family agreeing to participate in the program. This will

include individual sessions scheduled with parents/guardians and family meetings. ACT 360 can be utilized as a frontline prevention service as well as an intensive intervention service.
