SELF PAY FEES

- **Intake appointment:** \$175 (55-75 minutes)
- **Therapy:** \$125/session (approximately 53-60 minutes; rates for shorter sessions are available upon request: \$62.50 for up to 30-minute session; \$93.75 for up to 45-minute session).
- **Non-billable activities** (e.g., report writing requests, phone calls, court appearance requests): \$25 per 15 minutes
- * **Late cancellation (less than 4 hours)/ no-show appointment:** \$75 per session

⇒ **We accept private pay for services in the form of cash or debit/credit cards.**

OUTSTANDING BALANCE POLICY

1. If an invoice remains unpaid after 1-week, weekly calls/ emails will be made to remind them of outstanding balance. Past due invoices may result in suspension of services until resolved. Payment plans may be arranged upon request and approval by Evolution. Please see the Evolution Office Manager for details.
2. If an invoice remains unpaid after 30 days, a letter will be sent requesting payment. The letter will include a clear deadline for payment and will notify the client that failure to pay by this date will result in the invoice being sent to collections.
3. If payment is not received by the deadline specified in the formal letter, the invoice(s) will be sent to the Credit Control Collections in Altoona, PA.
4. Evolution will no longer attempt to contact client. All attempts to collect payment will be handled from Credit Control Collections.
5. If Evolution receives payment from client, agency will notify Credit Control Collections of payment within 10 business days of receipt. If Credit Control Collections receives payment, they will notify Evolution.
